

The Government of the United Republic of Tanzania under the Ministry of Water and Irrigation has set aside funds for the implementation of Water Projects in Sikonge District Council during the financial year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Construction of Water treatment plant at Igumila Dam and Water supply infrastructures at Kapumpa and Mgambo villages in Sikonge District Council.
2. Sikonge District Council now invites sealed bids from eligible Civil Engineering Contractors registered with Contractors Registration Board from class six and above to carry out Construction of Water treatment plant at Igumila Dam and Water supply project at Kapumpa and Mgambo Villages

3. Tendering will be conducted through the National Competitive Bidding specified in the Procurement Regulations, 2013 Government Notice No. 446 and is open to national bidders only all Tenderers as defined in the Regulations unless otherwise stated in the **Tenders Data Sheet**.
4. Interested eligible Tenderers may obtain further information and Tender Documents at the office of the **Secretary of Tender Board, Sikonge District Council, P.O.Box 70, Sikonge**. From Friday 11<sup>th</sup> May, 2018; at 07.30hrs to 15.30hrs on Mondays to Fridays inclusive except on public holidays.
5. A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers from the address given under paragraph 4 above and upon payment of a non-refundable fee of Tshs. 100,000.00;(One hundred thousand shillings only) per Lot. Payment should either be by Banker's Draft, or Banker's Cheque, payable to District Executive Director at Sikonge District Council. 6. All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.

All Tenders in one original plus Two copies, properly filled in, and enclosed in plain envelopes must be delivered to the address **Secretary of Tender Board, P.O.Box 70, Sikonge**; at PMU office along Works Department at or before 10.30hrs, Thursday 24<sup>th</sup> May, 2018. Tenders must be clearly marked Lot number. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening, at the Works Department office room.
8. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
