The Sikonge District Council has received funds from the Government of United Republic of Tanzania for the cost of **Construction of THREE IN ONE SEMI DETACHED STAFF HOUSE URBAN TYPE** at Sikonge District Hospital. It is intended that part of the proceeds of the fund will be used to cover an eligible payment under the Contract for which the Bidding Document is issued.
11. The Sikonge District Council now invites sealed bids from eligible Contractors registered in **Building Contractors Class IV**.
12. Participation is open on equal terms for Building Contractors currently registered with Contractor's Registration Board.
13. Bidding will be conducted through the **National Competitive Bidding (NCB)** procedures, specified in the Public Procurement (Goods, Works, Non Consultant Services and disposal of Public Assets by Tender) Regulations, **2013** - Government Notice No. **446** and is open to **National Bidders** only as defined in Regulation.
14. Interested bidders may obtain further information from and inspect the tender documents at the Office of the District Executive Director, P.O. Box 70, Sikonge, Tabora, from 8.00am to 3.30pm on Monday to Friday inclusive except on public holidays.

15. Tender Evaluation will be conducted through tender evaluation procedures specified in the Tanzania Public Procurement Act No. 21 of 2004 (Goods, Works and Non-Consultant Services) and its Regulations and Tender Evaluation Guidelines (Procurement of Works and Goods).
16. A complete set of the tender documents may be purchased by interested on the submission of a written application to the District Executive Director, P.O. Box 70 Sikonge, Tabora, and upon payment of a non refundable fee of Tshs 100,000/= (Tanzania Shillings one hundred thousand only). Payment should be made either by Banker's Draft, Cash or Banker's Cheque payable to the District Executive Director, P.O. Box 70, Sikonge, Tabora.
17. All bids in **ONE ORIGINAL plus TWO COPIES**, properly filled in and enclosed in plain sealed envelopes must be delivered to the following address:
